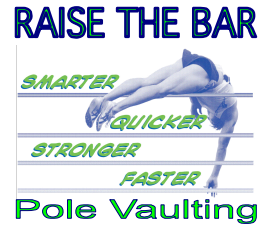

Team Participation Agreement and Release of Liability Waiver

I and/or my child/children are voluntarily participating in the high energy, physical activities offered by Jump N Shout and Pacific Athletics Cheer, LLC. I am aware that our participation in these activities, including all offerings at the Jump N Shout and Pacific Athletics Cheer facilities including but not limited to inflatable equipment, games and toys, is potentially hazardous and involves numerous risks of injury. I understand that "Reno Elite" is the name I compete under but I am a member of Jump N Shout and all fees paid are to "Jump N Shout".

In consideration of our participation in the activities at Jump N Shout and Pacific Athletics Cheer I, and my heirs, freely accept and assume all risks, both known and unknown. I agree to release, defend, indemnify, not sue and hold harmless Jump N Shout and Pacific Athletics Cheer, its owners, employees and agents, from any and all liability for damages, injuries, wrongful deaths and expenses arising from our voluntary participation at Jump N Shout and Pacific Athletics Cheer, or the voluntary participation of those for whom I am responsible, whether or not such injury or death was caused by alleged negligence of the parties released.

I am aware of the risks of participation, which include, but are not limited to, bodily injury, strains, fractures, partial and/or total paralysis, heart attack, and death. I hereby state that I and my child/children are in sufficient physical condition to accept a rigorous level of physical activity. I understand that participation in activities offered at Jump N Shout and Pacific Athletics Cheer is strictly voluntary and I freely choose to participate. I and my child/children willingly agree to comply with all safety guidelines and rules as a condition for participation. I verify that I will be responsible for any medical costs I or my child/children incur as a result of our participation, or the participation of those for whom I am responsible.

By executing this document I agree to hold the parties released harmless and indemnify them in conjunction with any injury or loss of life or property that may occur as a result of engaging in the activities acknowledged above. I hereby declare that I am of legal age and am competent to sign this Agreement or, if not, that my parent or legal guardian shall sign on my behalf and that my parent or legal guardian is in complete understanding and concurs with this Agreement.

I allow JUMP N SHOUT TO USE PICTURES of my child taken during a party for promotional purposes. I understand that I will receive occasional promotional items about Jump N Shout and Pacific Athletics Cheer at the above information.

I am aware of the financial agreement and contract. I understand that I must drop my child in writing by the 20th of the month. I am responsible for any early withdraw fee if I am on team as outlined in the financial agreement. I understand that any fees paid are non-refundable. I am responsible for any tuition posted after the 20th, if I drop after the 20th.

I AM AWARE THAT THIS CONTRACT IS LEGALLY BINDING AND THAT I AM RELEASING MY LEGAL RIGHTS BY SIGNING IT.

Medical Release

In the event that medical attention is needed for myself, or a minor participant listed above, I authorize the Jump N Shout and Pacific Athletics cheer staff to administer basic first-aid. In the event that advanced first-aid is required, Jump N Shout and Pacific Athletics Cheer will call 911 and I authorize medical treatment as required. I agree to release Jump N Shout and Pacific Athletics Cheer from all claims, damages, injuries and expenses arising from contact needed to administer medical assistance.
